# EXECUTIVE ORDER

Effective Monday, March 30, Seminole County's Social Distancing Order allows businesses to remain open pending the following conditions:

a) All employees and patrons must practice social distancing by staying at least six (6) feet apart;

b) Group meeting and/or training sizes must be limited to ten (10) people or less;

c) Limit occupancy to 30% of the maximum allowable capacity under the fire code, for non-residential, non-medical, and non-lodging uses; and

d) Checkout points and staging areas, including store fronts, must be monitored for social distancing requirements by means of marking floors or similar actions to maintain six (6) feet distance between customers.

#### PENALTIES

Businesses and individuals that do not comply with this Order on a consistent basis are subject to monetary fines up to \$500 per occurrence. Repeat violations could result in mandatory closure pursuant to Section 72.6(b)(1)(F), Seminole County Code, and other applicable Florida Statutes. Can be enforcement by code enforcement and law enforcement officials.

#### EXCEPTIONS

This Order does not apply to first responders, healthcare/medical workers, veterinarian staff, shelter/rehab staff, utility providers, food service workers, childcare providers, transit and construction.

#### MINIMUM STANDARDS FOR INDIVIDUALS

Social gatherings must be limited to no more than ten (10) persons.

#### VIOLATIONS

# COVID-19 TESTING

#### STEPS FOR TESTING

COVID-19 tests are only facilitated with a physician's order for patients who meet the evaluation criteria as defined by the Centers for Disease Control and Prevention. Physicians are stringently adhering to the testing criteria set by the Centers for Disease Control and Prevention to determine if a patient qualifies for a COVID-19 test. A doctor will likely test you for other illnesses, such as the flu, before ordering a COVID-19 test. Unless you are experiencing severe respiratory distress, such as shortness of breath or chest pain, you should not go to an ER for a COVID-19 test.

#### DRIVE-THRU TESTING

Regional partners have assisted with executing a state and federally-managed drive-thru test site at the Orange County Convention Center. This community-based test site is led by U.S. Department of Health and Human Services (HHS) and will be limited to 250 tests per day. The site opens daily at 9:00 a.m. and will remain open until 5:00 p.m. or until 250 individuals have been swabbed.

Testing will be available ONLY for first responders, healthcare workers and symptomatic individuals age 65 and older.

- For individuals 65+:
  - Must have an on-site temperature of 99.6 degrees or higher and respiratory symptoms
  - Must have an ID to be tested
- For first responders and medical staff:
  - Do not have to have COVID-19 symptoms
  - Must have valid agency ID

For those who visit the site, be prepared to wait inside personal vehicles for extended wait times. There are no bathrooms on site. Test results will not be provided on-site. Please DO NOT call Orange County Convention Center for information.

#### CITY HALL LOBBY CLOSED

As a safety precaution and to prevent the spread of COVID-19, the City Hall lobby is closed to the public until further notice.

#### CLOSED/CANCELLED/SUSPENDED

- City Hall Lobby until further notice.
- Winter Springs Senior Center and Therapy Pool until further notice.
- City Park restrooms and splash playgrounds until further notice.
- Explore Outdoors (Tree Giveaway program will be rescheduled).
- City facilities, fields, and park pavilions rentals through April 12.
- City events, activities, and programs are canceled through April 12. Suspensions include but are not limited to adult sports, youth sports, recreation classes, and police programs.
- Employment services such as interviewing and hiring have been suspended until further notice. We are still accepting applications, but will not be interviewing.
- Fingerprinting Services until further notice.
- Police Explorers Meetings until further notice.
- Citizen's Advisory Committee April meeting.

#### **CITY PARKS**

City parks are open at this time for general use (restrooms and splash playgrounds are closed). However, staff strongly recommends all users exercise extra caution when in any public area and continue to use elevated hygiene protocols.



#### CONSERVE WATER

While we're spending time at home social distancing, **remember to conserve water**. 1) Follow the Water Restrictions schedule for daylight saving time.

- 2) Turn off the faucet when you're not using it.
- 3) Run the dishwasher only when it's full.

#### WHAT'S FLUSHABLE?

The short answer is **No. 1, No. 2, and toilet paper**. Sewer systems are designed to take away wastewater from sinks and baths and take away toilet paper and human waste flushed down the toilet. Items such as

disposable wipes, paper towels, tissues, disposable diapers, feminine products, cotton balls, bandages, prescriptions, cleaning wipes or trash of any kind can create blockages in sewers or damage to the environment by putting it down the toilet. Despite being advertised as 'flushable,' disposable wipes are NOT meant to be disposed of in a toilet.

#### **RECYCLING SERVICES**

Residents should sort recyclables before placing curbside. Seminole County Solid Waste generally offers curbside sorting, but for the safety of collection crews, asks customers to self-sort.

Tissues and paper towels should be placed with regular household garbage. Fibers should be sorted together. This includes:

- Pasteboard (i.e., cereal boxes, empty paper towel and toilet paper rolls, soda boxes, beer boxes, tissue boxes, gift boxes, pizza boxes and shoe boxes)
- Brown paper grocery bags (no wax, no wet strength material, no liners)
- Corrugated cardboard (flattened and cut down to fit inside the recycle bin)
- Newspaper, supplements, magazines and catalogs



- Box board, carrier stock, white and colored paper
- Telephone Books

Co-mingled containers should be sorted together. This includes:

- Plastic Containers #1-7 (#'s on bottom of containers) Remove all lids
- Glass bottles and jars (clear, green and brown) Remove all lids
- Aluminum cans
- Steel cans and tin household containers, such as food cans

### PREVENTION



#### 1) Wash Your Hands Often

Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing. A trick to know if you've washed long enough, is by singing the birthday song until you've finished washing.

#### 2) Practice Social Distancing

Assume that everyone has the virus and avoid close contact. Put 6-feet in distance between yourself and other people if COVID-19 is spreading in your community. Avoid hugs, handshakes, gatherings of ten or more people, and close quarters.

#### 3) Clean and Disinfect

Clean and disinfect frequently touched surfaces daily. This includes tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, and sinks. If surfaces are dirty, first clean with detergent or soap and water, and then disinfect.

#### 4) Stay Home and Cover your Mouth

Stay home if you are sick, except to get medical care. Cover your mouth and nose with a tissue when you cough or sneeze or use the inside of your elbow. After, immediately wash your hands with soap and water for at least 20 seconds.

#### 5) Call Before You Go

Call your doctor or your County Health Department if you think you have been exposed to COVID-19 and develop a fever and symptoms, such as cough or difficulty breathing. Tell them about your symptoms and your exposure. They will decide whether you need to be tested.

#### 6) Rumor Control

Do your part to the stop the spread of disinformation by doing three easy things; don't believe

the rumors, don't pass them along and go to trusted sources of information like www.coronavirus.gov or www.prepareseminole.org to get the facts about the COVID-19 response.
