

During the month of December 2015, the following ordinances, contracts, agreements, and resolutions were approved by the City of Winter Springs City Commission:

#### **Ordinances:**

 The City Commission adopted Ordinance Number 2015-23, which granted a Non-Exclusive Solid Waste Franchise to WCA of Florida, LLC. ("WCA") to provide solid waste disposal services to school facilities owned and operated by the School District of Seminole County, Florida and located within the jurisdictional limits of the City.

#### **Contracts/Agreements:**

 The City Commission authorized an agreement with Power Exterminators, Inc., for neighborhood parks chemical services.

#### **Contracts/Agreements (continued):**

- The City Commission authorized the City to enter into a contract agreement with WM Mitchell Construction Development Inc., for the construction of the Utility/ Public Works Administration Building on Old Sanford Oviedo Road.
- The City Commission approved The Huntington Company to perform repairs to Plant #1 at the East Water Reclamation Facility.
- The City Commission approved a plat for Winter Spring Farm, a three (3) lot residential subdivision, and authorized the Plat to be recorded.
- The City Commission accepted the 2015 Florida Department of Law Enforcement Justice Assistance Grant (JAG) in the amount of \$14,085.00.
- City Commission The approved Preliminary/Final Engineering Plan, Aesthetic Review, and the First Modification of the Development Agreement for a total of 279 multifamily units located on the east side of Tuscawilla Road. north State Road 434 of and west of Michael Blake Boulevard.
- The City Commission approved the Conditional Use for an accessory dwelling unit located at 320 Hayes Road.



# FEATURE ARTICLE

#### City of Winter Springs 2015 Water Use Summary

#### **Potable Water (Drinking Water):**

The City of Winter Springs serves 33,430 residents with an average of 3,560,000 gallons of water each day through 13,347 active potable water connections. We have 168 miles of potable water lines transporting water from 3 water treatment plants to homes and businesses throughout the City. The City's source of drinking water comes from the Floridan Aquifer (groundwater). Water is pumped from the aquifer using 8 different wells located throughout the City. The water is treated with aeration and chlorination using liquid chlorine. Aeration removes hydrogen sulfide from the water. Chlorine is used to disinfect the water to ensure that a clean, safe product is delivered to your home. In 2015, the City of Winter Springs distributed 1,246,910,000 gallons of potable water to the public, which is a 6.5% increase in distribution as compared to the 2014 calendar year. We received 68 inches of rainfall in 2015; 7 inches more than in 2014. The annual water use in 2015 was 33.5% below the St. Johns River Water Management District Consumptive Use Permit allowance of 1,664,400,000 gallons. Factors contributing to the increased water demand may include additional residential development, such as the Seven Oaks subdivision and an increase in existing home sales.



#### City of Winter Springs 2015 Water Use Summary (continued)

#### **Reclaimed Water:**

Winter Springs currently has approximately 1,711 reclaimed water connections. Reclaimed water is produced at two wastewater treatment facilities within the City. These facilities treat all the grey water, such as from showers, washers, and sinks, as well as sewage. The wastewater is treated to a degree that it is free of bacteria and other contaminants and is then supplied back to the public in the form of reclaimed water. Excess reclaimed water that is not used by utility customers is recycled to any of the five percolation ponds or spray fields throughout the City. These are areas where water is allowed to percolate into the ground and back into the aquifer. Production of reclaimed water for the 2015 calendar year totaled 761,815,000 gallons, which is a decrease of 0.3% from 2014. Of this total, 523,879,000 gallons were distributed for irrigation, which is an increase of 0.02% from 2014, while 237,936,000 gallons were recycled to the percolation ponds and/or spray fields, which is a decrease of 4.6% from 2014.



# FEATURE ARTICLE (CONTINUED)

#### **Notice Regarding Trihalomethane Levels in Drinking Water**

As a utility customer of Winter Springs, you have been receiving quarterly notices notifying you that the level of Total Trihalomethane (TTHM) in the drinking water is above the maximum contaminant level (MCL). Below are some common questions and answers pertaining to TTHM.

- 1) Why did I get this notice? Recent Federal regulatory changes mandate notification when TTHM in the drinking water exceeds the Environmental Protection Agency (EPA) standards. While the quality of the drinking water has changed very little over the last 20 years, what has changed in 2014 is the methodology required by EPA to calculate compliance levels.
- 2) What is TTHM and can it give me cancer? TTHM is a by-product of drinking water disinfection that forms when the chlorine used to disinfect the water reacts with naturally occurring organic compounds. The EPA has regulated these disinfection by-products (DBPs) since 1979 to address health risks posed by a potential association between chlorinated drinking water and cancer, particularly bladder cancer. Current data does not support a conclusion as to whether exposure to chlorinated drinking water or disinfection byproducts causes adverse health effects. Although uncertain, the combined health data warrant EPA's DBP rule to mitigate potential health risks.
- 3) Does this notice affect me since the out of compliance sample locations are not near me? The EPA designated sampling locations which represent the four most remote locations within the entire 173 miles of the water distribution system where the chlorine has the longest time to interact with naturally occurring organics in the water and form the TTHM. Although only two sample locations failed to be in compliance, a public notice must be mailed to all 13,000 residences and businesses in the City's service area since the City's three water plants are all interconnected. Although the water delivered to most customers is below the compliance threshold, any violation triggers notification to all customers as required by the EPA.
- <u>4) Can I drink the water?</u> Yes, you can drink the water. Monitoring and regulation for the level of TTHM in the drinking water was implemented by the EPA as a precautionary measure to mitigate potential health concerns from long term exposure.
- 5) Can I boil the water to eliminate TTHM? No, boiling the water will not eliminate or reduce TTHM levels.
- <u>6) Does filtering the water work?</u> Yes, using a granular activated carbon filter, i.e. whole house, refrigerator, drinking pitcher style, or single canister can reduce or eliminate TTHM.
- 7) What is the City doing about this and will it increase my water rate? The City's water treatment personnel are addressing the TTHM MCL exceedance by increasing flushing to reduce water age, optimizing chlorine levels, and reconfiguring chlorine injection points and well run cycles. By April 2017, the City will have completed water treatment improvements at a projected cost of \$6,000,000 to eliminate the TTHM MCL exceedance, as required by the Florida Department of Environmental Protection. Currently, these anticipated water treatment improvements are expected to require an increase in the water rates of approximately 15% after completion of the project.
- 8) My water has a sulfur smell. Is that related to the TTHM violations? No, the sulfur odor is from naturally occurring sulfur in the ground water supply. Although a slight reduction is anticipated when the treatment plant improvements are completed in 2016, some odor will likely remain. The sulfur smell is not a regulatory issue and the construction of additional treatment improvements to completely remove the smell would be at the discretion of the City. If desired by the residents, completion of these improvements would likely require some increase to the water rates.

#### Texting and Driving: A Dangerous Choice

Florida State Statute 316.305 states:

"A person may not operate a motor vehicle while manually typing or entering multiple letters, numbers, symbols, or other characters into a wireless communications device or while sending or reading data on such a device for the purpose of nonvoice interpersonal communication, including, but not limited to, communication methods known as texting, e-mailing, and instant messaging. As used in this section, the term "wireless communications device" means any handheld device used or capable of being used in a handheld manner, that is designed or intended to receive or transmit text or character-based messages, access or store data, or connect to the Internet or any communications service as defined in s. 812.15 and that allows text communications. For the purposes of this paragraph, a motor vehicle that is stationary is not being operated and is not subject to the prohibition in this paragraph."

In 2015 there were 6,734 crashes in Seminole County with 4,690 resulting in injury. Distracted driving is a poor choice and should not be taken lightly. March and April were the heaviest months with 612 and 604 respectively.

Texting while driving is not a primary offense. That is, if you are texting and driving and it results in a moving violation (failure to maintain a single lane, violation of a traffic control device etc...) your traffic stop is the result of a moving infraction caused by your texting and driving. The fines begin at \$30.00 and are cumulative. So, if it is your second offense, you will be fined \$60.00 and receive 3 points on your license. Should your texting and driving results in a crash, your license will be assessed 6 points.

So, this spring, get off the phone before you get behind the wheel. If it is so important you cannot wait, pull off the road for a few minutes and deal with the issue. When you text and drive, you put everyone at risk.

# CITY OF WINTER SPRINGS CONSTRUCTION PROJECTS UPDATE



#### **Active Projects**



#### **Cross Seminole Trail:**

• The Cross Seminole Trail has a missing link from Layer Elementary to the west end of Old Sanford/Oviedo Road. The planned connection will continue from the current terminus at Layer and run northerly adjacent to SR 419. The City has received a revised survey for the adjacent property and has submitted that survey to the state for review.

#### Magnolia Park Amphitheater:

• The Magnolia Park Amphitheater is proposed to be constructed at the eastern end of Blumberg Blvd. Construction is anticipated to begin in fall 2016 with completion expected in early 2017.



#### **Assisted Living Facilty:**

• The City is working with the Hawthorne Group for a proposed assisted living facility. The facility will consist of 144 units with congregate dining and entertainment options. Engineered plans are scheduled to be submitted in the second quarter of 2016.





# CONSTRUCTION PROJECT UPDATE (Cont.)



#### The Greens at Tuscawilla:

• The 60 unit townhome project is located on Winter Springs Blvd. adjacent to the Tuscawilla Country Club. The project is approximately 93% complete with one building remaining to be built.



#### Jesup's Landing:

• The project consist of 171 townhomes in 30 building units on 17 acres of land located on the south side of Orange Ave., behind Winter Springs High School. Construction is ongoing and the project is approximately 90% complete.





# CONSTRUCTION PROJECT UPDATE (Cont.)



#### **Opportunity Sites:**

• Winter Springs offers excellent opportunities for the development of high technology industries. Situated on the eastern edge of the City, Seminole Way is a strategic economic development initiative focused on attracting high value jobs and businesses to Seminole County. The State Road 417 (Central Florida Greeneway) corridor defines the boundaries of the Seminole Way district, spanning the length of Seminole County and connecting to both Orange County's "Innovation Way" and the "Medical City" located at Lake Nona. The City has targeted this Greeneway Interchange District (GID) for technology industry development complemented by commercial and retail establishments. It is expected to become a premier employment center with professional and high tech office buildings, conference facilities, and hotel rooms. The GID opportunity site is comprised of 26 potential sites with over 378 acres. One of the key features of this opportunity site is the ease of assemblage: it offers the largest consolidation of vacant developable land within the City under the ownership of only 3 land owners.

# CONSTRUCTION PROJECT UPDATE (Cont.)



#### Plante Property (Tuskawilla Crossing):

• The proposed project will include approximately 373 residential units comprised of traditional single family detached homes and detached bungalow units on lots ranging from 34ft. to 70ft. in width. In addition, the project will include a commercial component. Staff is working with the applicant on final modifications to the site design. At the 10/26/15 meeting, the City Commission approved a Special Exception for 16 single family units in the T5 (Town Center Zone) of the Town Center. In addition, the first reading of the Future Land Use Amendment for the the church property at 395 Tuskawilla Road was approved and changed from Public/Semi-Public to Low Density residential. Zoning remains PUD for the property. Staff is curently working with the applicant on the master plan for the parcel.

#### **Pollack Shores Apartments:**

• Final engineering is was considered by the Planning & Zoning Board on December 2nd, 2015 and was approved by the City Commission on December 14th, 2015. Construction is expected to begin in the first quarter of 2016.

# The RiZE at Winter Springs:

• This project is located east of City Hall in the Winter Springs Town Center. Construction on the residential units is underway. Occupancy of the first units is scheduled for March 2016.

#### **Seven Oaks Subdivision:**

• The project consist of 138 single-family units located on the south side of Shepard Road, north of Florida Avenue, east of Boat Lake, near the City's boundary on U.S. HWY 17-92. Construction of the residential units continues. Approximately 91% of the 138 units have been constructed or permitted.





# Southern Oaks Subdivision:

The Southern Oaks subdivision. consist of a 50-acre development, with approximately 92 houses near the Oviedo and Winter Springs boundary along SR 434. Site work on the Winter Springs portion of the project is expected to commence in early 2016.
