## TITLE

Presentation from Kittleson and Associates on Widening of State Road 434

## SUMMARY

Kittleson & Associates was contracted by Seminole County to perform a State Road 434 Corridor Planning Study for two sections of State Road 434. Section 1 is from State Road 417 to Franklin Street, which encompasses Winter Springs and Oviedo. Section 2 is from Smith Street to Mitchell Hammock Road and encompasses Oviedo and Seminole County.

The purpose of this meeting is for Kittleson & Associates to present the Corridor Study Overview, Future Conditions Report Findings for both sections of the study, and discuss the next steps beyond the Corridor Planning Study.

A separate public meeting will be held in July 2019 to further discuss this study update.

## RECOMMENDATION

Staff recommends the City Commission receive and review the information provided by Kittleson & Associates.
